Coskun Can Aktan is currently working as full-professor at the Faculty of Economics and Management, Dokuz Eylul University. He is also founder and currently Honorary Chairman of the Social Sciences Research Society (SOSRES), a non-governmental organization.

He worked at several international research centers and universities including the Center for Study of Public Choice, George Mason University (USA); Economics Department of the University of California (USA) ; International Social Sciences Institute of the University of Edinburgh (UK) and Institut für Allgemeine für Wirtschaftsforschung of the University of Freiburg (Germany), Vrije University (Belgium), Mount Kenya University (Kenya) as a visiting scholar.

Aktan's research studies were funded by the fellowships and the grants of such organizations as Higher Education Institution of Turkey, Turkish Scientific and Technical Research Institution (TUBITAK), Turkish Sciences Academy (TUBA), George Mason University Foundation (USA), Earhart Foundation (USA), British Council (UK), German Academic Exchange Service (DAAD (Germany), Friedrich-Naumann Foundation (Germany), Japan Foundation (Japan), Soros Foundation (Hungary).

He currently serves as an associate at the Center for Business and Public Sector Ethics, Cambridge, UK ; an associate at the the International Association of Cybercrime Prevention, Paris, France; a research associate at the School of Public Management, Governance and Public Policy of University of Johannesburg (South Africa).

He served as the Conference Chair of the Annual Meeting of the European Public Choice Society (EPCS).

Professor Aktan served as member of Trustee Board at Yasar University between 2004-2008.

He served as board member of University Research Fund, Dokuz Eylul University for several years.

He was a consultant to the Telecommunications Authority, a regulatory body in Turkey between 2003-2005. He also served as an "Advisor to Health Minister" and contributed to the "Turkish Health Care Transition Program" in the years between 2003-2006. During his work at Ministry of Health, he initiated an e-library on health-care services , which is the most comprehensive database on health services and health sector in Turkey.

Professor Aktan is a prolific writer and a regular contributor to scholarly journals in Turkey. His research ranges across many fields within social sciences, and includes works on Public Choice, Constitutional Economics, Institutional Economics etc.

He founded and served as editor-in-chief of the several journals including Journal of Public Choice and Constitutional Economics, Journal of Telecommunication and Regulation. He is currently the Founding General Editor of the Social Sciences eJournals Archive.
